## A Story of Generosity



Before long we will be able to move into our new fellowship hall! As we look forward to using our beautiful new space, we need to be planning for the costs involved in "living" in that space. Our best estimate of the cost of operations (utilities, maintenance, etc.) is approximately \$10,000 for the first six months. Our long-term plan is to offset some of our annual fellowship hall operational expenses with rental revenues once the building is open and functional.

To help us transition into that time, two of our very generous Church couples have pledged \$5000 each to cover the operational costs for fiscal year 2017 (July 1, 2016 to June 30, 2017). We are so grateful for their contributions which will allow us to focus the new and increased pledges in our FY17 budget on helping us strengthen our fiscal foundation, compensating our staff fairly and planning for our yearly expected shortfall in pledge fulfillment. This unavoidable shortfall, common to all church congregations, results from church members' deaths, moves, unexpected changes in financial circumstances, etc. We are being proactive in this year's budgeting process by anticipating this shortfall.

So, we owe much gratitude to the generous contributions of our two special UUCK couples! Many thanks to them, and now let's all do our part to help our beloved Church "spring forward" into a wonderful future through our own generous contributions.

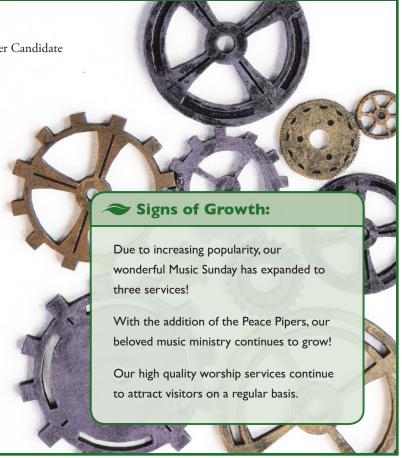

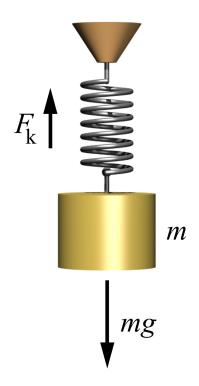

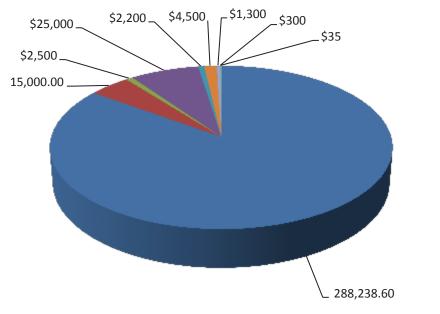


## Signs of Growth:

### What Projected Revenues Are Needed to Fund Our Programs and Ministries?

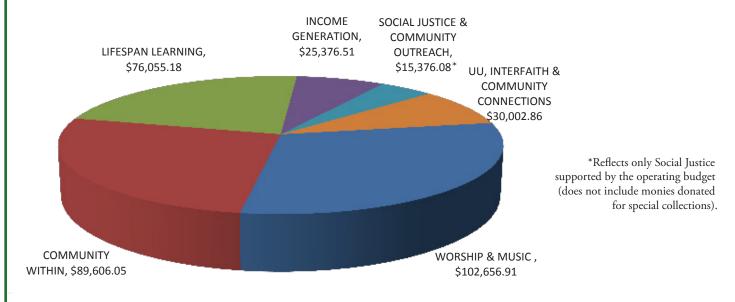

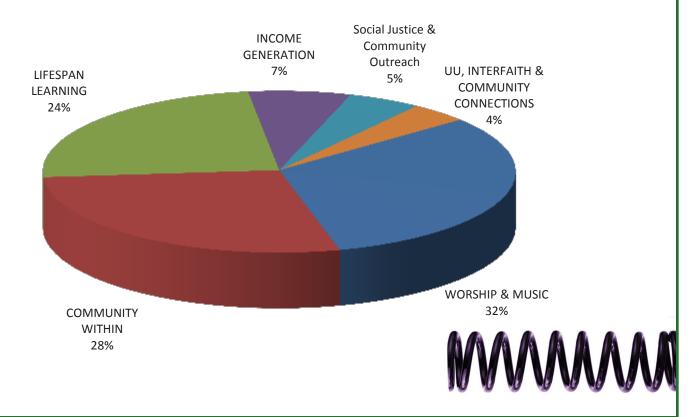
### Projected Fiscal Year 2017 Program Area Expenses Supported by Your Stewardship





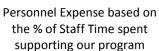

Based on the Percentage of Staff Time Spent Supporting Our Programs and Ministries



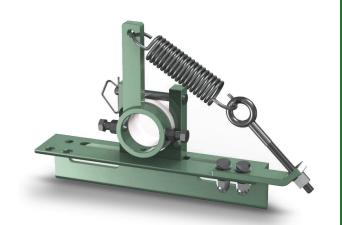
