

#### ANNUAL MEETING MINUTES OF THE UNITARIAN UNIVERSALIST CHURCH OF KENT June 5, 2011

The quorum was met so the meeting was called to order.

1. Last year's minutes:

Randy Leeson made a motion to accept the minutes of last year's congregational meeting and Lori McGee seconded it. It passed unanimously.

2. Leadership Development Committee:

Lori McGee explained a misprint in the Yearly Report, so it needs to be amended to state that Kristopher Sperry will be chair of this committee. <u>Also, the 2 year term for Kristofer Sperry for the Endowment Committee – should be 3 years.</u> Larry Cole moved that this amendment be made and Randy Leeson seconded it. This passed unanimously.

The nominees for the 2011-2012 Board of Directors are: Kathie Slater as Assistant Moderator, Kim Marfy as Board Secretary, Cheryl Spoehr as Trustee for Programming, Julie Lineburgh as Trustee for Fellowship and Colleen Norris as Trustee for Building & Grounds. Mac Goekler has agreed to serve 1 more year – to bring the board in bylaw compliance on position rotation.

Elaine Bowen made a motion to elect the slate as given and Randy Leeson seconded it. This passed unanimously.

- Unitarian Universalist Assoc. (UUA) and Ohio Meadville District (OMD) dues: Renee Ruchotzke, Affiliate Minister, made a motion to amend the budget to show full payment of the dues. <u>Bob Erdman suggested that this proposal be amended to reflect</u> <u>only those special pledges received by June 30, 2011. Renee agreed to this change.</u> Lori McGee seconded the motion and it passed unanimously.
- 4. Budget:

Kay Eckman presented the budget for FY 2011-2012. Elaine Bowen made a motion to accept the budget as presented and Christopher Gargoline seconded it. It passed unanimously.

5. Policy Based Governance:

Lori made a motion to continue the process of adopting the policy based governance which the Board has been working on the past three years. Kay Eckman seconded the motion and it passed unanimously.

6. Outgoing Board and incoming Board:

Christopher Gargoline asked the present Board to come forward. He presented Kristofer Sperry with a gift from the Board in thanks for all he has done for the church this past year as Moderator. He also thanked the Board for their hard work and dedication.


He introduced the members of the incoming Board and had them stand with the rest of us and then presented his goals for the coming year.

## **Revenues**



#### Policy Governance Task Force of the Unitarian Universalist Church of Kent Suggested by-law amendments April, 6, 2012

Between current Article IV. Meetings of the Membership and current Article V. Board of Trustees add new Article V. Governance and Ministry

#### Article V. Governance and Ministry

The congregation of the Church elects a Board of Trustees to function as its governing body and a minister to serve as its spiritual, programmatic and administrative leader. The intended style of leadership will be consultative, collegial and inclusive. All Church leaders are expected to practice transparent decision making, healthy conflict management, and mutual support in their respective roles. [insert italics]

#### Article VI. Duties of Officers and Trustees

Section 1. Moderator

The Moderator shall serve as Chief Governance Officer of the congregation and shall [insert italics] bears [delete underscore] overall responsibility with the Board for leading the governance of the church [insert italics]. for the general welfare of the Church and assists it toward its goals by overseeing the implementation of its plans and policies. [delete underscore] The Board of Trustees believes governance is a collective, democratic process that produces lasting policies designed to achieve the mission and well-being of the congregation. As much as possible, the board shall delegate management decision making and devote its attention to discernment, strategy and oversight. [insert italics]

The statement as currently written reads:

The Moderator bears overall responsibility with the Board for the general welfare of the Church and assists it toward its goals by overseeing the implementation of its plans and policies.

The revised statement, if adopted, would read:

The Moderator shall serve as Chief Governance Officer of the congregation and shall bear overall responsibility with the Board for leading the governance of the church. The Board of Trustees believes governance is a collective, democratic process that produces lasting policies designed to achieve the mission and well-being of the congregation. As much as possible, the board shall delegate management decision making and devote its attention to discernment, strategy and oversight.

#### Article X. Minister

Section 1. Roles of Minister.

The Minister shall serve as the Chief Executive Officer, leading and directing the spiritual, programmatic and administrative work of the Church in concert with the Ministry Executive Team. The Ministry Executive Team shall be led by the Minister and shall include the Congregational Administrator and the Treasurer of the Board of Trustees. The Ministry

Executive Team is hereby delegated authority and responsibility to make all operational decisions, adopt administrative policies, and allocate congregational resources except as

specifically limited by board policy. The Minister shall also serve as head of staff and be responsible for maintaining a productive and effective staff team, for ensuring that its efforts are directed toward fulfilling the congregation's mission and vision of ministry, and for staff compliance with all board policies. [insert italics] <u>be in charge of the religious and spiritual aspects of the Church, including regular and special worship services, ceremonies, celebrations, rites of passage and pastoral care. The Minister shall act as an advisor in Church matters, [delete underscore] *The minister shall* [insert italics] be a *non-voting* [insert italics] ex-officio member of the Board, and serve as an ex-officio non-voting member of all Councils and Standing Committees except <u>the Leadership Development Committee</u>, [delete underscore] the Interim Minister Search Committee, and the Ministerial Search Committee. [delete underscore] The Minister shall be in fellowship with, or in process of obtaining fellowship with, the Unitarian Universalist Association. The Minister shall have freedom of the pulpit.</u>

#### The by-law as currently written reads:

The Minister shall be in charge of the religious and spiritual aspects of the Church, including regular and special worship services, ceremonies, celebrations, rites of passage and pastoral care. The Minister shall act as an advisor in Church matters, be an ex-officio member of the Board, and serve as an ex-officio non-voting member of all Councils and Standing Committees except the Leadership Development Committee, the Interim Minister Search Committee, and the Ministerial Search Committee. The Minister shall supervise other staff, and perform such duties as usually pertain to the position. The Minister shall be in fellowship with, or in process of obtaining fellowship with, the Unitarian Universalist Association. The Minister shall have freedom of the pulpit.

#### The revised by-law, if adopted, would read:

The Minister shall serve as the Chief Executive Officer, leading and directing the spiritual, programmatic and administrative work of the Church in concert with the Ministry Executive Team. The Minister shall be in fellowship with, or in process of obtaining fellowship with, the Unitarian Universalist Association. The Minister shall have freedom of the pulpit.

#### Bylaw revision related to Minister's assessment

The committee on Ministry recommends the following change in the By-Laws:

P.7

Article VI Duties of the Officers and Trustees

Section 1. Moderator

9. Participate in the (annual) delete regular add review of the minister.

The by-law currently reads:

9. Participate in the annual review of the Minister.

If adopted, the revised by-law will read:

9. Participate in the regular review of the Minister.

#### P.16

Article VIII Committees that report Directly to the Board

Section 2. Committee on Ministry

Beginning in line 10:

The chair of the committee serves on the panel that conducts an assessment of the Minister's engagement with the congregation as part of an (annual) delete **regular** <u>add</u> review and renewal of the leadership and ministry of the congregation.

The by-law currently reads:

The committee evaluates the total ministry of the church to assess how it is living out the congregation's mission. The committee selects its own chair. Annually, the Board will appoint members from a slate prepared by the Minister and Moderator. The Minister serves as an ex-officio member of the committee. The chair of the committee serves on the panel that conducts an assessment of the Minister's engagement with the congregation. Upon calling a new settled Minister, the board shall appoint as the next member someone who served on the Ministerial Search Committee that selected that ministerial candidate.

The Committee and the Minister will discuss any needed changes to the letter of the agreement. The Moderator will report to the Board that this has occurred and provide a copy of any written review for enclosure in the minister's personnel file in the church office with a copy given to the minister.

<u>add (In the case of a newly called settled minister the designated committee will conduct an</u> annual review for the first five years of the minister's tenure. Following successful completion of those assessments biannual review will take place.)

#### Reports from the Staff: The Rev. Melissa Carvill-Ziemer

Last year as I wrote my annual report, the work of our congregation's Expansion Committee was coming to an end as the work of the Capital Campaign Committee was preparing to begin. The Expansion Committee submitted its final report at our last annual meeting with a recommendation that we explore on site expansion. We decided that we needed another group of people to pick up where the Expansion Committee left off and that their charge would be to rigorously explore the feasibility of on-site expansion.

The Feasibility Team was formed last summer and includes Christopher Gargoline, Kathie Slater, Kay Eckman, Mac Goekler, Cheryl Spoehr, Randy Leeson and me. We decided that we needed professional architectural assistance to assess the feasibility of on-site expansion. After issuing invitations to eight architectural firms, we received and evaluated three bids from which we ultimately selected the Kent based Fuller Design Group. The first step in the process included both a structural assessment as well as an asbestos survey. After receiving positive news from those two assessments, we asked the Fuller Design Group to give us initial sketches and an estimate for the sanctuary reorientation project. We were very pleased when that estimate came in within a realistic range for our congregation's financial means. We then asked the Fuller Design Group to prepare sketches and estimates for the cost of constructing a new fellowship hall. The location of the fellowship hall we envisioned depended on acquiring adjacent property. Once we evaluated the first set of sketches and estimates and realized that project too was potentially within our means, we began the process of approaching our neighbors about purchasing property.

One of our neighbors has agreed to sell us a portion of their lot, but the other property we hoped to acquire is not available at this time. Thus we have returned to Fuller Design Group with a request for a second set of sketches for a new fellowship hall, utilizing a different design based upon the results of our efforts at property acquisition. We are currently awaiting the second set of sketches and accompanying financial estimates. We already have a good sense of the cost of renovating our existing fellowship hall for religious education classroom space. Thus, the information about the revised fellowship hall plan is the last piece of the puzzle we are awaiting before we approach the congregation with a comprehensive plan for on-site expansion.

While all of this has been happening, the Capital Campaign Committee has been busy laying the foundations for our campaign and inviting donations to help seed our efforts. The Capital Campaign Committee currently includes Amy Edmonds, Randy Leeson, David Smeltzer and me. We have plans to double the size of the committee over this summer as we enter the next phase of our work. Our work this past year included speaking with selected members of the congregation in a position to help seed our capital campaign fund. We knew that we would need funds readily available in order to acquire property and pay our architect, real estate attorney and other professionals. The response to that request was very positive and we are extremely grateful to our early campaign donors who together have committed approximately \$100,000. These funds are being carefully administered in a separate capital campaign account and are not available for use for general operating expenses.

In the winter and spring, the committee turned its attention to the process of hiring a capital campaign consultant. We educated ourselves about the services we could expect from a consultant and the campaign process as well as made inquiries of other Unitarian

Universalist congregations about consultants we might consider. We interviewed consultants from three different organizations and then ultimately recommended to the Board of Trustees that we hire the consulting services of the Unitarian Universalist Association (UUA). We were very impressed with the mission of the UUA financial consulting services and feel confident that their experience assisting Unitarian Universalist congregations in meeting their capital campaign goals will be invaluable to us. Our consultant, William Clontz, will be with us for an initial Assessment Weekend June 8-10. You can read more about the purpose and anticipated outcome of this visit in the June edition of the Chalice Flame newsletter.

Meanwhile, the life and work of our congregation goes on! Other building improvements we are celebrating this year include the new shed (with its new, level foundation), our new tables and chairs and our plans for new front doors for the church. With any luck, the new doors will be in place before summer officially begins. Less physical but equally valuable is our redesigned website. The website is the place that new folks to our congregation see even before they see the front doors. It is imperative that we have a strong, fresh and engaging web presence and we are incredibly grateful to Jennifer May and Dan Flippo for making it so.

In addition to our complete website overhaul, we also completely revamped our approach to our annual stewardship campaign this year. The Finance Committee, chaired by Gene Wenninger, led the charge to make the transition from a line item based budget to a mission based program budget. We researched the implications and process of making such a change and spent the fall laying the infrastructure, which included a time study by each member of the staff. The staff then worked with the wonderful campaign co-chairs Sandy Eaglen and Marion Yeagler to organize the information we needed to communicate in our new form. The ever so talented couple Saul Flanner and Kathy Walker once again graciously agreed to do the layout and design of our campaign materials. These were shared first with a 25 person team of visiting stewards and then sent to every member and active friend of the congregation. The outcome of this new approach has been fantastic. We have had the best stewardship campaign we have had in years and, as a result, we are finally going to achieve our goal of paying our full fair share of Annual Program Fund dues to both the Unitarian Universalist Association and the Ohio Meadville District in this next fiscal year.

Our staff has been a big part of achieving our successes of the past year. MaryBeth Hannan, Karen Lapidus and Hal Walker are all talented, dedicated and experienced professionals and we are very lucky to have them working with us. Additionally, after serving as our contract nursery worker for several years, we have made Michelle Bores a part of our staff. After so many years of dedicated service, we felt this was in the interest of right relationship. We were sorry that our sexton Cindy Vair's tenure with us was so brief. However, we are grateful to Michelle Bores for filling in as our volunteer sexton while we searched for and hired our new sexton, Deb Biggins. Deb is an excellent addition to our staff team and it is my sincere hope that we won't be looking to hire anyone else for a good long time.

Of course, none of our ministries would be possible without the time, energy and dedication of so many incredible lay leaders. For the past three years a wonderful team of lay leaders have participated in the Congregational Growth and Vitality Consultancy Project for mid-sized congregations. This program has involved participating in two overnight retreats per year with ongoing work and monitoring phone calls between retreats. Our team has changed shape a bit since we began with the addition of Kathie Slater and Ann VerWiebe. Christie Anderson has remained as a member of the project along with Marion Yeagler, who has faithfully served

as our coordinator. Several leaders from our congregation have also participated in the six session Healthy Congregation series offered in our cluster by the Ohio Meadville District.

Taking advantage of opportunities like these is one of the ways we learn about next steps we can take in strengthening our congregation's health, growth and vitality.

This year we implemented Food for Thought groups as an extension of our small group ministry program. (Lori McGee came up with the idea at one of our Growth and Vitality retreats!) Over the last six years many members and friends of our congregation have gotten to experience the joys of small group ministry by participating in our Chalice Group program. Chalice Groups are a wonderful way of having meaningful conversations about subjects that matter with other folks in the congregation. However, we have come to realize that the highly structured format of our Chalice Group program does not appeal to everyone. We piloted the Food for Thought groups as an alternative to Chalice Groups for those who prefer a looser structure and would enjoy having conversation over meals. We had three Food for Thought groups this year and the feedback from participants has been very positive. We look forward to offering both Chalice Groups and Food for Thought groups again next year. If you are hoping to expand your relationships with others in the congregation, I strongly encourage you to participate. I think these groups are among the best ways of developing meaningful relationships with others in the congregation.

Transitions are always a part of congregational life. This year we experienced a transition in the leadership of our Helping Hands Network. After two years of service, we thanked Mary Ann Kasper and Stephanie Summers for their co-coordination of our Helping Hands Network. We are so pleased that Swanny Voneida and Colleen Thoele have agreed to become the new co-coordinators of this important part of our caring ministry.

As your minister I am honored to lead many of the rituals that mark the personal transitions of your lives. This year I joyfully officiated the unions of Rosie Herman and John Skocdopole and Meg Milko and Deb Biggins as well as the dedication and blessing ceremonies of Ava Zavodny, Ben Hovancsek, Miles Hager, Kailani Song Li Walker and Paxton Rex Beale. As a community we grieved the loss and celebrated the lives of three among us – Gordon Forrest Vars, Robert Wood and Beth Sholtis. Each of them will be greatly missed. I also officiated the memorial service for Carol Gould's beloved husband Edwin Gould. He too will be greatly missed.

Our ministries reach in and out. In addition to our work among us, I have had the pleasure this past year of continuing to serve on behalf of our congregation in the larger community. I have continued on as a member of the Kent Social Services Advisory Board and Karen Lapidus and I have shared responsibilities for our membership in the Kent State University Campus Ministers Organization. I have continued my participation with the interfaith William Williams Workshop (formerly the Sacred Conversation on Race) and once again participated in the CROP Walk. Through Ted and Swanny Voneida I have been connected with FaCT (Faith Communities Together – formerly Faith Communities Anti-Fracking) and have supported the work of Concerned Citizens Ohio: Frack-Free Kent. This past fall Kat Holtz and I participated in a special Kent Community Dinner highlighting the area GLBT community and we are already scheduled to participate in another such dinner in October 2013!

In addition to my work within our congregation and community, I remain involved in several forms of denominational service. Last summer I served as the Transformational Multicultural

Sensibility Lens Leader at two Unitarian Universalist Leadership Team Institutes (intensive leadership development trainings for Unitarian Universalists). At our annual General Assembly

(GA) I had the opportunity to participate as a panelist in a workshop called "Unfurling Moral Imagination" and to serve as a member of the GA Right Relationship Team. This year I have been invited to serve as a co-chair for our GA Right Relationship Team. I am also completing my three year term as a member of the Unitarian Universalist Ministers Association Nominating Committee, this year as chair. My work with Unitarian Universalist Allies for Racial Equity continues as I become President this year at GA. In that role I also will serve on the UUA Moderator's Council on Cross Cultural Engagement. Finally, I will be continuing on in my role as a member of the UUA's Western Regional Subcommittee on Candidacy (an evaluative body in the credentialing process for aspiring ministers) and have accepted the invitation to serve as chair of the committee.

My work at the associational level is a wonderful opportunity not only to serve this faith tradition I cherish, but also to grow in my own leadership. That is part of the reason I so strongly support lay leadership development opportunities. I know from my own experience that the chance to grow has abundant rewards for the communities we serve. I love Unitarian Universalism, I love our church and I love the ministries we are tending together. I look forward to another rich and wonderful year ahead.

As I write this report, I reflect back on another wonderful year working with the children and youth of our beloved church. It is such a honor to partner with so many dedicated volunteers who serve our young UU's with respect and love.

We have 110 children and youth who participate in our program. Our average weekly attendance is 49. On Sunday morning, we offer nursery care at both services, a multi-age activity during the first service and a full RE program for preschool, grades 1-3, grades 4 & 5, middle school and high school, during the second service. Throughout the fall and winter, we offered *Our Whole Lives (OWL),* which is our program of comprehensive sexuality education, to seven of our children in grades 4 and 5. Having two separate rooms for the library has added a sense of calm in the nursery, since we have more space and the options of having quiet activities in one room and more lively ones in the other.

The Religious Education Committee continued with their good work this year. The members--Mary Leeson (chair), Michelle Bores, Beth Kuemerle, Tanya Kahl and Kat Holtz--partnered with me to support the Halloween Party and Youth Group Haunted House, offer the Surprise Friends multigenerational mixer, host the two events for the RE teachers, sponsor the Christmas giving projects to support the residents of Miller Community House and to collect toys for families through Kent Social Services.

The RE Committee and I hosted two events for our RE Teachers. Since then, we have had lots of books out in circulation. The RE Committee and I hope to add more books on Unitarian Universalism to our collection.

I support the Hogwarts Action Team by conducting the screening of their volunteer teachers. I also survey the class plans to assure that they align with Unitarian Universalist principles and values. It has been a wonderful experience to work with these folks who are so enthusiastic about the Harry Potter literature and strive to present high-quality, safe and awesomely fun programming to the children of our church and of the Kent community.

As my ministry, I am continuing to serve the Unitarian Universalist Association in lay leader development. I work mainly in the Central East Regional Group (CERG) which includes 4 districts and covers most of Ohio, northern Virginia, and the states of New York, Pennsylvania, Maryland, West Virginia, Delaware and New Jersey. I work from home about 2/3 of the time and travel the other 1/3. I lead workshops, webinars, weekend trainings and work directly with Threshold Congregations.

#### Reports from the Board: Trustee for Outreach to the Wider World

The Outreach to the Wider World (OWW) council consists of the Social Justice Committee (SJC), Denominational Affairs (DA), and the Time Bank Action Team (TBAT). Sally Burnell chairs the SJC, Kristina Spaude leads the TBAT and Mac Goekler is our DA coordinator.

The SJC's mission is to select and implement Social Justice Projects and Issues that reflect our Church's covenant, mission and vision, and that are in accordance with our UUA seven principles, and are supported by our Church's congregational resolutions. In addition, the SJC picks a monthly Social Justice Special offering recipient. There is some variance here in that we sometimes have two offerings (when there is great need) in a month and sometimes the special offering is for a non-social justice cause (as in UUA Organization Sunday).

A time bank is a service exchange networking organization where members exchange services with each other hour for hour. Our Church is an institutional member of the Kent TimeBank. This last year we put our Kent UU TimeBank on sound footing. We created an operational policy for the TBAT. We used this policy generating exercise as a learning opportunity. The Policy Governance Task Team (I'm a member) needed a policy template and used the TimeBank policy as its first example of a policy using the template. TimeBank continues to grow and many of the organizational and introduction meetings were held in our Church.

Denominational Affairs acts as liaison for the congregation with the UUA, the Ohio Meadville District and other UU organizations. Denominational Affairs actually had a meeting this year. Usually, the Sunday Morning Adult Exploration forums are used as a venue to supply the congregation's input to the UUA for various Social Justice issues that are before the UUA, but this year we convened a DA workshop to produce the needed feedback on both the current Study Action Issue (Immigration as a Moral Issue) and the selection of the next four year Study Action Issue.

We had a transfer of leadership on the Social Justice Committee – Caroline Arnold stepped down and by consensus Sally Burnell became the new chair. The SJC continues to support many causes, including Green Sanctuary, the Occupy movement, Single Payer Health Care (SPANOhio), Immigration Reform, and Anti-Fracking.

The SJC was asked to present a Sunday Service on Social Justice. Caroline Arnold, Paulette Thurman, and I presented a service in January 2012 titled, "Social Justice: Then and Now". In addition, Kat Holtz and I were invited by the West Shore UU Church (through Ellen Carvill-Ziemer) to conduct a discussion on Child Slavery and Chocolate following a showing of the documentary, "The Dark Side of Chocolate". Caroline Arnold has started an open Social Justice Forum – during Sunday second service.

The SJC generates "income" though the sale of Fair Trade coffee, tea, chocolate, and olive oil. The SJC continues to supply coffee, etc. for the Church's Sunday coffee hour. The SJC also donated \$500.00 to the Church's general fund. Saunis Parsons, our devoted Fair Trade manager noticed that some of our chocolate was disappearing and found that we had some chocolate loving church mice. We now have a locked cabinet for our chocolate. We also purchased Saunis a new table.

It has been my privilege to serve as your Outreach to the Wider World Board Trustee for the last three years.

If there is one word that sums up the Programing Block for this year, that word is – Change.

Whether actively or more passively, all the committees and teams within this block have been pursuing transformation. The Vespers Committee has been on hiatus, assessing new ways to meet the needs for non-Sunday worship within our community. Similarly, the Adult R.E. committee has taken a step back to better reorganize and provide excellence in Adult Religious Exploration next year. Several Adult R.E. series were offered, the topics ranging from one's own personal spirituality, to the more social justice oriented subjects of immigration and the world food supply network. The Chancel Decorations committee is newly reformed, but still in the process of self-definition. The Music Committee is similarly reforming after a long period of quiet, and big things are on the way once it is completely together.

On a more active note, the Youth Religious Exploration Committee has had an overflowing year. Plans were made to focus on the second service for formal curricula, while the first service has offered a looser agenda. The Youth R.E. Committee has managed to include within this year its semi-annual offerings of O.W.L., or Our Whole Lives, training young people for a lifelong application of our values, as well as Coming of Age. Various service projects were included as part of these and other packages, giving the children both fun and meaning as they learn to reach out to the larger community.

Hogwarts has returned to the official Harry Potter "cannon", and found itself with literally more applicants then space for them. While there has been some talk of moving, Hogwarts has chosen to stay in the time-honored Mason's manse for now. In addition to giving fun time for children and "Professors" alike, Hogwarts spreads both good will and experience with our church and our values beyond the borders of our religious community.

The Aesthetics Committee has made a decision to go beyond the emotional value of the artwork upon our walls, premiering new, and sometimes controversial art. The artwork is expressive of our values, often mirroring the themes of the services.

The Sunday Programming Committee has blended lay-led services lead from within our own ranks with pulpit exchanges from other U.U. churches, as well as refocusing on guest speakers. The formats of these services are challenging and new, including a theatrical interpretation of "Charles Darwin", and readings of theological fiction by guest Ministers. These add variety to our Sunday morning services.

Where's Walden continues its mission of bringing our congregation into the "Church of Nature". Those who don't actually participate can still have the vicarious blessings of this experience when those who have return and share their recent discoveries with them.

#### Feasibility Team 2012 Annual Report

The Feasibility Team was created in May 2011 to explore the possibility of staying on site to reach the congregation's Vision of Physical Expansion. Towards this goal, the group met many times. We invited several architectural firms to make proposals for an assessment of the current condition of the Church building and its suitability for expansion. Three firms responded and after discussions and comparisons, the Team chose the local Fuller Design Group.

Working with their construction company, Metis Corporation, Fuller studied and explored the condition of our building and deemed it suitable and sound for renovation and reorganizing with an eye to the original floor plan for the main level. General costs estimates were made that were within the parameters thought reachable for our capital campaign. Preliminary drawings were presented for both the Church and a new Fellowship Hall.

At this point, the Feasibility Team began negotiating with two neighbors with a goal of purchasing land to enable the building of the Fellowship Hall. After coming to a preliminary agreement with one neighbor, we are currently working with a real estate lawyer as the next step in the process of buying a portion of the Dykes property (the property behind the Eldredge Annex). Since we are not currently able to purchase more property, we have asked the Fuller Group to submit a second set of drawings for a Fellowship Hall to be built on the site of the current Annex. There are several positive reasons for using this site: availability, savings on utilities, and the ability to have a connecting bridge to the main church structure.

Hopefully, at the 2012 Annual Meeting, we will be asking the congregation to vote on purchasing land and will also be sharing the first drawings of the Eldredge Annex/Fellowhip Hall building.

#### Finance Committee 2011-2012 Annual Report

The major activity of this Committee is always the annual Stewardship Campaign. This year's campaign began in December with a decision to implement a Program Budgeting approach. This had been recommended by the previous Finance Committee. Implementation involved a number of efforts by church staff and members – selection of a theme (Pie), production of a brochure, a study of staff time allocated to church programs, the translation of a line item budget into a program- focused budget, and the integration of this into the work of the Stewardship team.

The program budget required an initial line-item budget. The solicitation of budget requests for FY2013 from all members with budget authority was done in December and January, and the initial draft budget assembled in February. This, plus the staff time allocation study, was the input for the brochure, which was produced and mailed to all members late February, early March. A strong Campaign leadership team was recruited, and a very successful campaign conducted. In mid-April the initial line-item budget was revised to reflect the successful campaign, and as of this writing was ready to go to the Board and then the Congregation

Other highlights: Again following on a previous Finance Committee recommendation regarding retention of financial records, a recommendation was sent to the Board and approved by it to place a seven year cap on retention. Another recommendation was sent to establish a separate money market account to hold capital campaign contributions and other long-term deposits. An audit of Church employee records by the Bureau of Workman's Compensation indicated a need to have the Minister also carry the title of Chief Executive Officer. A recommendation was sent to the Board, approved, and is awaiting congregational action.

Staffing needs and compensation levels were reviewed and recommendations forwarded to increase work hours for the congregational administrator and sexton, and to adjust salaries selectively to remain in line with new UUA guidelines.

#### Church Library Committee Annual Report 2011-2012

Once again the church year was busy for the library committee. Present members are: Martha Kluth, Chair; Kathy Wilen, Secretary; Ann Waters, Publicity; Carolyn Schlemmer, Cataloger; Matt Cox and Andrew Bores.

To provide more space for the nursery program we moved the library to the Founders Lounge in January, 2012. The children's book collection was moved from the Annex and made available to the public adjacent to the adult books in the Lounge. The two collections share a returns box, but the circulation of each collection is administered by the separate division.

Ann Waters, Library Publicity, has done a wonderful job for us and has worked to initiate our public programs. The library hosted two such programs this year. In October, Dr. Tom Dukes, Professor of English at the University of Akron, read from his book, Sugar Blood Jesus. In February our speaker was Dr. Dan Roland, Assistant Professor at the Kent State School of Library and Information Science and Primary Researcher for the Center for the Study of Information and Religion (CSIR) hosted by the school. His topic was "Communication and the Fear Factor." Both programs were well-received and followed by refreshments and conversation.

Changes this year include the following. We added the category "Religious Studies" to our list of subjects in the library collection. Our circulation process was refined this year. We improved our tracking of overdues and now have a dated return slip that can be inserted in

each book. Matt Cox and Martha Kluth took on the job of updating our material on the church website and posting news items about the library. They have trained with webmaster Dan

Flippo this spring. We have also undertaken the publication of the new UUCK periodical, Here We Have Gathered. This "chapbook" will focus on our Kent UU Church history.

We would like to develop our library collection to a greater degree than we have this year. Each month any new books of interest that we add have been put in the section to the top left of the shelves entitled "New Books in the Church Library". The titles are also featured in our column in the Chalice Flame. The donation of a variety of magazines from Denise Snyder-Markovitch has been much appreciated. We are presently cataloging CD's of Summer Institute speakers received from Bob Erdman and Larry Cole. Kathy Wilen worked to process these items.

# **Policy Governance Team**

For the last few years, the Board has been investigating the concept of policy-based governance as an approach to managing the vision, mission, and responsibilities of the church. Currently, many congregations, including several local Unitarian Universalist Churches, have adopted policy-based governance and have found it effective in their churches. After discussions with lay leaders from these churches and consultants from the ML district, the Board asked the congregation's approval to further investigate policy-based governance during a trial period in the 2010. Unfortunately, other priorities supplanted the work of this team and another trial period was requested for this year.

Policy-based governance is a disciplined approach to empowerment within a congregation. Its primary focus is to make the board more efficient and focused in their work, adding value to what they do rather than merely processing work. Under the policy-based governance model, the board responsibility is transformed from a required "rubber stamp" to strong leadership meaningfully interacting with the ministry to support the articulation of the Church's mission. Policy-based governance provides a rationale for clarity in interactions by defining roles, accountabilities, and guidance through established policies. Being policy-based will allow quicker response, more consistency in decisions, and clear expectations about desired outcomes.

This year, good progress was made in testing the policy-based governance approach. The Board operated as if the structure was already in place, deferring decisions to policies where available, and to the leadership of teams and committees. The Policy-based Governance team created diagrams of the new structure and the approach which will be used to define new policies and amend existing ones. They worked on definitions of roles and created straw models of structural interactions. Additionally, they defined the policy formation policy and designed a tool to be used in the definition of policy. More importantly, they piloted the policy formation process as well as the tool and the approach. This pilot included bringing the tools to the Board for review and approval of the trial policy. A brief summary of that work follows.

Under policy governance, two distinct areas of leadership exist, the Board and Ministry. Our current structure will be re-conceptualized from councils under the leadership of trustees who report to the Board, to committees and teams functionally aligned with either the Board in Fiduciary accountabilities or the Ministry, in the work of the congregational mission. Policies from either the Board or Ministry side will guide the operation of the church, through staff members and volunteers (see attached diagram). Essentially, decision making and responsibility for leadership in the church moves from the Board and makes teams and committees responsible for good stewardship within their areas of focus. To this end, configurations of committees and teams have been revised (see attached list). Overall, the Board retains overall fiduciary responsibility for the health and well-being of the church. The role of the minister becomes more like that of a chief executive officer, with an enlargement of responsibilities as committees and teams on the ministry side shift their reporting relationship from the Board to the Minister.

In 2012, as the work of the Policy-based Governance team continues more work on the infrastructure of the church will be done. This work to include the modification of processes and interactions required for full implementation of the policy-based governance approach.





On January 20, 2012, the Social Justice Committee, along with the Single Payer Action Network of Ohio, showed the film "The Healthcare Movie" at our church, along with a pot-luck dinner prior to the showing of the movie. Despite a raw winter night, the estimated attendance was around 30.

On May 18 of this year, the committee will sponsor a teach-in on hydraulic fracking and the devastating environmental effects of this technology.

So far, these are the only programs we have put on but I do hope that we can do more in the future. I have asked the committee to please plan ahead three to six months for programming due to our limited space and heavy usage of the church and annex house.

We have yet to do anything with our space on the new church web site. We need to assign someone to take care of that for the committee.

Mac Goekler is currently teaching a six week course on the Doctrine of Discovery that is still being used today with regard to immigration issues.

Member Paulette Thurman, with financial assistance from the Social Justice Committee, attended the Community Environmental Legal Defense Fund Democracy School in March. She is heavily involved in the anti-fracking movement and it was felt that this could be beneficial to the church to send one of our members to this series of workshops.

Our committee has recognized the need to support the Move to Amend, the group that is fighting the Citizens United Supreme Court ruling and we are hoping to perhaps work on a draft statement owing to the fact that this might eventually become a UUA Study/Action issue in a few years.

There are so many issues of concern that it could easily become overwhelming. Fortunately, each individual member of the committee seems to have his or her own special area of interest on which they are working and members report on those activities during committee meetings, helping all of us to stay informed on issues for which we have no time to be involved, from health care to environment to poverty and more.

Speaking of poverty, one issue that I would very much like to see our committee to more work on is in helping people to find ladders out of poverty and how to become more self-sufficient so that they no longer need to rely on the rapidly fraying social safety net. I don't know enough to know what causes this, but perhaps the committee can work on this and find out what the causes of poverty are and try to address those things as best we can. I hope to make this our goal for the next year, to identify and then see if we can address the causes of local poverty and do our best to try to alleviate some of it.
