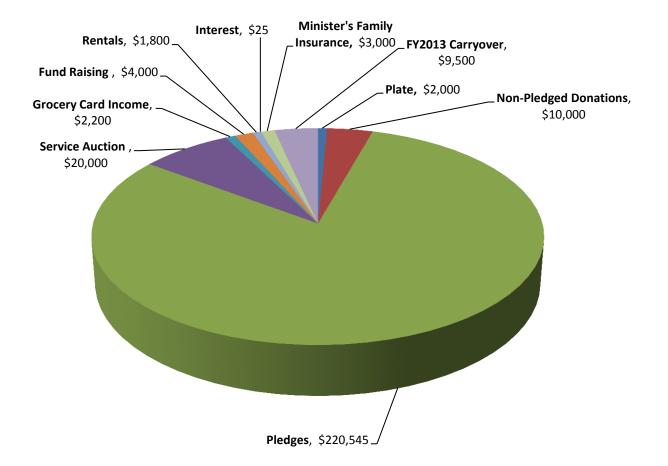
Christopher thanked all who served this year. Kathie Slater thanked all outgoing trustees. Kathie Slater offered closing words to end the meeting.

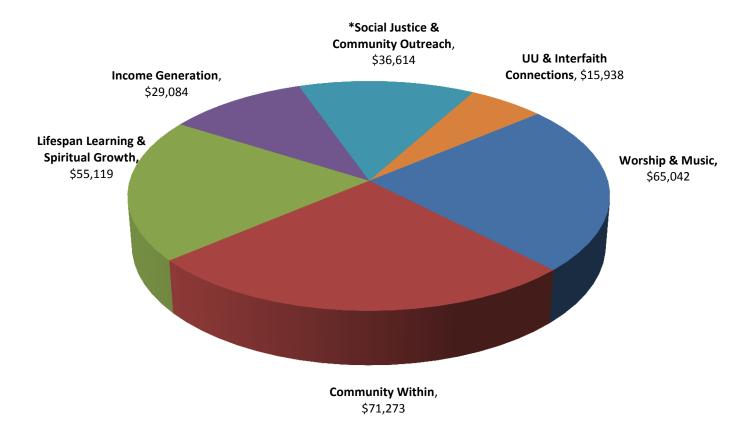

#### Section 3. Personnel Committee

The Personnel Committee handles employment-related matters pertaining to church paid staff. Duties of the committee include: developing personnel policies and procedures for board approval, handling employee questions and complaints, preparation of employee contracts, ensuring that employees are evaluated, and preparing and updating employee job descriptions for board approval, maintaining up-to-date information on comparable employee wage rates, and making recommendations on employee compensation to the Finance Committee for consideration in preparing the budget. The committee consists of three members appointed by the board for a term not to exceed three years. The committee selects its own chair.

#### The Personnel Committee is proposing the following amendments to the bylaws:

#### Section 3. Personnel Committee

The Personnel Committee handles employment-related matters-sets the employment policies pertaining to church-paid staff of the church. Members will develop a policy that governs how funds are invested and submit the policy to the Board for approval.

Members will solicit contributions and handle investments in accordance with an approved investment policy. The Endowment Committee recommends to the Board disbursements from the legacy fund(s). Both the Endowment Committee and the Board must vote to approve any disbursements. If the Committee determines that a proposed donation is not in the best interest of the church, it may recommend to the Board rejection of a gift. The Committee shall consist of three active church members elected by the congregation to serve staggered three-year terms. The Endowment Committee shall meet at least two times a year to review financial reports of the legacy fund(s), plan ways to increase contributions, and consider any requests for disbursements. The Committee shall submit an annual report to the Congregation stating the status of any legacy fund(s) and reporting any disbursements.

#### The Endowment Committee is proposing the following amendments to the bylaws:

#### Article IX: COMMITTEES REPORTING TO THE CONGREGATION

#### Section 3. Endowment Committee

The Endowment Committee shall oversees one or more legacy funds Endowment Funds that receive gifts, bequests, proceeds of charitable trusts and/or similar contributions donations intended for the long-term needs benefit of the church. Members The Committee will develop a policy that governs how funds are invested and dispersed and shall submit the policy to the Board for approval.

Members The Committee will shall solicit contributions donations, in consultation with others, and handle allocate investments in accordance with an the approved investment policy. The committee shall prepare a ballot listing nominees for each elective office, and a succeeding Leadership Development Committee to be voted upon at the Annual Meeting. The Congregation at the Annual Meeting shall elect the committee, consisting of a chairperson and four other members serving staggered two year terms. One member shall always be the immediate past Moderator, who will serve a one year term. The members shall be currently active in the Church. The committee shall prepare a ballot listing nominees for each elective office, and a succeeding Leadership Development Committee to be voted upon at the Annual Meeting. The nominees will be given a copy of the By-Laws and directed to read the section pertaining to the office of their nomination.

#### If approved, the revised bylaws would then read:

#### Article IX. COMMITTEES REPORTING TO THE CONGREGATION

Section 2. Leadership Development Committee.

The Leadership Development Committee, in addition to proposing the slate of candidates for positions on the Board, the Financial Secretaries, and the Endowment Committee, will provide the congregation with educational opportunities designed for leadership development throughout the church year. The Congregation at the Annual Meeting shall elect the committee, consisting of a chairperson and four other members serving staggered two year terms. One member shall always be the immediate past Moderator, who will serve a one year term. The members shall be currently active in the Church. The committee shall prepare a ballot listing nominees for each elective office, and a succeeding Leadership Development Committee to be voted upon at the Annual Meeting. The nominees will be given a copy of the By-Laws and directed to read the section pertaining to the office of their nomination.

#### Reports from the Staff: The Rev. Melissa Carvill-Ziemer

This last year at the Unitarian Universalist Church of Kent has been marked by growth in so many ways. We have had growth in numbers with an increased membership and the largest budget ever in the history of the congregation. We have had growth in the health of our systems with changes to our governance and commitments to plan financially for the future. We have had growth in spirit with both new and revised ministries and programs. And we have had growth in our associational relationships with fulfillment of our commitment to pay our full fair share of Annual Program Fund dues and with members of the congregation connecting with Unitarian Universalism beyond our church walls. We are doing very well, and we should be proud of our many accomplishments!

Though we haven't accomplished the mission yet, we continue to work hard on our goals for expansion. The clear preference of the majority of the congregation is to expand on-site. Knowing this gave us confidence to invest in the beautiful new front doors to the church which proudly proclaim our welcome to all who would join us in our efforts to live caring lives of meaning and purpose. It was such a pleasure to dedicate the new doors in a celebratory service last August!

As a refresher, our expansion goals are to restore our church to its original orientation and reclaim the balcony and the Founders Lounge as part of the sanctuary space, to convert Fessenden Hall into space for our religious education programs, and to build a new social hall and kitchen on adjacent property. To date we have worked with a construction company, an architectural firm, land surveyors, and an attorney as part of our efforts. We have confirmation that our current building is structurally sound and able to accommodate our desired renovations. We also have architectural sketches of two different building designs for the new fellowship hall, depending on the exact location. We are now in the process of closing on the purchase of 68 square feet of property directly behind the annex. The only thing we need now to move forward is one more piece of adjacent property. We have plans in place with our attorney and will be moving forward with this next step just as soon as the current purchase closes. My great hope is that we will be able to move on from the property acquisition phase of this project very soon. We will, of course, keep you posted just as soon as there is news to share.

Another ongoing process for us has been our efforts to strengthen our governance structures. Last year the congregation voted to allow us to experiment with some of the guiding principles of policybased governance. For the Board of Trustees, these changes have created more room for a focus on mission and vision. For me these changes have created more opportunity for alignment between responsibility and authority through the creation of the Ministry Executive Team (MET). The MET is made up of myself, congregational administrator MaryBeth Hannan, and treasurer Sandy Eaglen. We meet monthly and have used that time to respond to many of the operational concerns that used to make their way to the board table for feedback and approval. We feel that we are still learning how to distinguish what belongs most clearly with which body, but the close communication between the board and the MET has allowed us to make this an ongoing conversation. We are looking forward to another year of experimentation and hope to bring you some bylaw revisions to ratify the best practices coming out of this experiment a year from now.

You may remember that one part of our expansion process included bringing a UUA consultant to visit with us for an Assessment Weekend last June. Our consultant, Bill Clontz, spent an intensive weekend with us meeting with a wide cross section of congregational leaders. From that visit and the many

written materials we sent him to review, Bill generated a report for us lifting up our successes and encouraging us to work on areas needing improvement. The leaders of the congregation carefully reviewed that report and made plans to follow up on his recommendations.

One area needing development had to do with our financial health. Bill expressed concern that, despite being in existence for almost 150 years, we have not had a meaningful endowment fund. We responded to that concern by creating a plan and a pathway for investment in our future. Our new Legacy Committee has launched two projects. The Simple Gifts project provides ongoing opportunities for members and friends to support our endowment fund by honoring someone through a gift to the fund. Over the course of this year many members and friends have elected to give Simple Gifts, and the result has been over \$1,000 in contributions to our endowment! In addition to Simple Gifts, we have also created the Heritage Program. The Heritage Program encourages planned giving to the congregation. Now that the Endowment Committee has finalized policies guiding the management of the endowment fund, we feel confident inviting members to consider remembering the church in their wills or with other planned gifts. Thanks to Carol Gould for taking the lead in our Legacy Committee. Carol is in the process of recruiting a few more members to share with her in this important work. We plan to provide more information about how you can take part in our Heritage Program very soon.

Bill sounded another note of financial caution regarding our lack of planning for major building repairs. We were able to respond to this concern because our FY13 stewardship campaign was such a great success. With a 22% increase in giving and a surplus from the previous fiscal year, we were able to set aside \$10,000 in a new contingency fund which is not to be used for day-to-day operations. One other note of financial caution had to do with our stewardship campaign. Bill noted that we had just concluded a great campaign, but that the results of our campaigns in previous years were lackluster. He urged us to put the systems in place to ensure that we had another great campaign this year. Thanks to the leadership of Marion Yeagler, Kay Eckman, and Sandy Eaglen, we did indeed have another wonderful stewardship campaign for FY14! With a 6% increase in giving levels, we have been able to budget for a new Religious Education program assistant, feeding our Contingency Fund, a modest 1% cost of living adjustment for staff, and the maintenance of our fair share giving levels. Thanks to all of you for responding generously to the invitation to support our mission and ministry.

In addition to the financial concerns, Bill also noted that our Social Justice and Adult Religious Exploration ministries were in need of revitalization. We responded to those concerns by reorganizing both of these ministries for greater involvement and effectiveness. You can read more about the structure and accomplishments of each later in this report. Though not specifically mentioned, we also felt the need to revitalize our Care Team. That process was accomplished over the winter, and we are looking forward to being of even greater service to the congregation. Many thanks go to Patty Miller for stepping forward to serve as the coordinator of our Care Team.

Part of our caring ministries involves honoring the milestones that mark our lives. This year we have had the pleasure of celebrating the weddings of Brad Bolton and Christie Anderson and Christopher Gargoline and Kristina Spaude. I also officiated at the weddings of Beth Schoonover and Scott Lenthe and Ian Hupertz and Jillian Flippo (Dan Flippos's sister). One of the many wonderful things about having Rev. Christie Anderson serving as our Commissioned Lay Leader is that I have been able to refer wedding ceremony requests of people who are not affiliated with the congregation to her knowing that she will represent Unitarian Universalism at its best! In other joys this year, we had the opportunity to celebrate the blessing and dedication of two babies, Norah Lang and Gray Hollis. Our sorrows included grieving the death of long time beloved church member Pat Pownall. I also officiated at the memorial service of Harry Kuhne, Evelyn Sperry's father.

I am anticipating an important milestone in my own life this fall as my spouse Evin and I prepare for the birth of our first biological baby. The planning process for my maternity leave is currently underway, and I will be sure to share the details with you as plans are finalized. Though I will be on leave during October, November, and December, I have great confidence that the church will continue to grow and thrive during that period. My confidence comes from the knowledge that we have strong lay leadership and an outstanding staff. Rev. Christie Anderson and Rev. Renee Ruchotzke, our Affiliated Community Minister, have both offered to provide leadership for some of the Sunday services while I am away. And our paid staff will see to it that the areas they work in continue with the high quality leadership you expect and deserve.

Over this past year, I have continued my service on the Kent Social Services Advisory board and have been especially glad to be involved in an effort to secure funding for outdoor lockers for people who are chronically homeless in our community. Along with Karen Lapidus, I have also continued to be involved in the Kent State University Campus Ministers Organization. The bulk of my commitments beyond the congregation, though, are located within the larger Unitarian Universalist world. Last summer I served as the co-chair of the Right Relationship Team at General Assembly and co-led a workshop with Saunis Parsons at Summer Institute. This summer I will co-lead morning worship at Summer Institute with my spouse Evin. I am completing my first year of service as the President of UU Allies for Racial Equity and also my first year as the Chair of the UUA's Western Regional Subcommittee on Candidacy. In addition I have begun participation in a selective two-year worship and preaching program sponsored by the Unitarian Universalist Ministers Association called "Beyond the Call". This program involves two in person gatherings per year for two years with conference calls, individual mentoring, and ongoing work in between. I am so grateful to have the time and the professional expenses resources for me to take advantage of professional development programs like these. Thank you for your continued support of me and my ministry. I am so very glad to be sharing in ministry with you.

#### Reports from the Staff: Karen Lapidus, Director of Religious Education

This church year has been one of both stability and anticipation. It feels stable because it is my fourth year serving as your Director of Religious Education. I feel the anticipation of our expansion project and all the opportunities that will bring. I continue to feel blessed to serve such a vibrant and mission-driven community of faith.

We have just over 100 children and youth participating in our Sunday morning RE classes and Tuesday evening OWL programs with an average weekly attendance of 48. (Attendance rates at around 50% of enrollment are typical for healthy Unitarian Universalist congregations.)

Our program wouldn't happen if not for all the wonderful and committed volunteers. We had 27 teachers and youth group advisors on staff this year. They include Mary Leeson, Amanda Rome, Lisa Slater, John Bores, Leah Gillig, Trudy Diehl, Marta Weist, Jacklyn Czekaj, Vivien Sandlund, Cheryl Spoehr, Andrew Rome, Sandy Eaglen, Joe Kuemerle, Lauryn Strabauur, Dani Beale, Renee Ruchotzke, Rhonda Richardson, Camille Pavilcek-Fauser, Bobbi Beale, Mary Ann Kasper, Lori McGee, Beth Kuemerle, Kristofer Sperry, Kat Holtz, Fred Smith, Kathy Walker and Saul Flanner.

Many thanks to our Sunday morning frequent helpers and substitutes who include Theresa Voneida, Shana Steinhouse and Laura McCrystal. Many parents stepped up throughout the year to help, as well.

Dan Flippo and I are leading three scouts through the *Love and Help* program, which is a collaboration between the Unitarian Universalist Association and the Boy Scouts of America.

Our summer 2012 program was "Stories That Inspire" based on popular children's literature. Folks who lead those sessions were Julie Macomber, Matt Cox, Becky Haines, Sandy Bowers, Kathy Kerns, Alan Kerns, Lori McGee, Jo Fachet, Kristina Spaude, Christopher Gargoline, and Dani Beale.

The little ones in our nursery are cared for lovingly and skillfully each Sunday by our Nursery Care Provider, Michelle Bores. Sandy Bowers volunteers to help in the nursery every Sunday and is joined by her daughter, Allison Norris every other Sunday. Other dedicated nursery volunteers this year are Kathy Kerns, Laura Teagle, Theresa Voneida, Natasha Swango, Beth Rowles, Mary Leeson, Trish McLoughlin, Don Easterling, Kathleen Gipson, Liz Bright, Noreen Kumm-Cory, and Alan Kerns.

Special thanks to John Kluth, for leading the children in drawing activities during social hour every Sunday.

As you see, it takes many folks to provide a program of religious education for children and youth!

The Religious Education Committee continued with their good work this year. The members are Mary Leeson (chair), Michelle Bores, Beth Kuemerle, Kat Holtz and Brandon Thoele. Our major projects were the Halloween Party and Youth Group Haunted House, the Surprise Friends multigenerational mixer and the Christmas giving projects to benefit both Freedom House and Kent Social Services. Please see Mary Leeson's report for more details.

The RE Committee and I hosted two events for our RE Teachers. We dedicated this year's Religious Education Program in loving memory of Gordon Vars and framed our two retreats with Gordon's educational philosophy in mind. In the fall, we considered the "seeds of learning" that the teachers

would plant this year. When we met for our winter retreat, we recalled how Gordon served as a mentor and inspiration to so many of us and then considered the characteristics of a valued mentor.

We used curriculum from a variety of sources:

UUA's Tapestry of Faith offerings: Love Will Guide Us in the Grades 1-3 class Families In the Middle School class Our Whole Lives (OWL) for Grades 7+8 on Tuesday evenings

Programs from independent UU authors and others: Spirit Play for Preschool and Kindergarten Chalice Theater and Peaceful Me for school-aged children at 2nd service Small Group Ministry and our own Chalice Group materials for HS Youth

During the regular church year, we continue to offer a Time for All Ages piece every Sunday during the worship service as well as the monthly multigenerational worship services. The "Emmet Otter's Jug Band Christmas" pageant and Youth Sunday were particular highlights for me.

The Children's and Family Library has been a useful resource for many of our families, but it is not used to the extent that I had hoped for. It is a wonderful and comprehensive collection and I encourage folks of all ages to peruse the shelves.

One particular joy this church year has been the level of involvement and leadership of our youth. Reid Parsons, Nikki Hurlbut and Noah Kerns serve on the Ohio Meadville District's Summer Institute Youth Panel. Joey Marfy and Gavin VanWinkle-Bright are leading workshops at Summer Institute. Joey Marfy has been trained to serve as a Peer Chaplains at district youth events. Jesse Beale Devine will attend the social service work camp in West Virginia for a second time. Additionally, both Noah Kerns and Connor May serve on the church's Fundraising Committee and Sophie Smith serves as a Worship Associate.

The Reverend Melissa Carvill-Ziemer and I alternated attending the monthly meetings of Kent State University's Campus Ministers Organization. Although our schedules and limited staff time did not allow us to offer any programming for students this year, we hope to keep our connection to the CMO's annual toiletry drive which benefits Kent Social Services.

My professional development activities focus mainly on my participation in the Liberal Religious Educators Association (LREDA). I attended the LREDA Fall Conference in Williamsburg, VA. In February, I completed my term as the retreat coordinator for the Ohio Meadville District LREDA Chapter. In April, I had the pleasure to attend a joint retreat in Chautauqua, NY with ministers and directors of religious education from both the Ohio Meadville and Saint Lawrence Districts. In June, I will be attending *The Vision & Practice of 21st Century Faith Formation* conference in Columbus.

In October 2008, I was "commissioned" by the Ohio Meadville District to serve our congregation as a Commissioned Lay Leader (CLL). A CLL is an unpaid volunteer who has completed an OMD-sponsored lay ministry program involving religious study and mentoring with a minister outside of the student's home church. As a CLL, my duties are negotiated with the UUCK Board. I work under the guidance of Rev. Melissa and I am accountable to the Committee on Ministry as well as the OMD's CLL Panel.

My present duties as CLL include leading two to four worship services per year for our church and serving as a referral source for Rev. Melissa for the performance of weddings and memorial services. As a member of the Pastoral team, I serve as a back-up for pastoral care needs in the minister's absence and I am a resource for congregants seeking information on local social services. In service to the UU denomination, I lead worship services at other area UU congregations.

This past church year began with my graduation from The New Seminary of Interfaith Studies in New York City and my ordination as an interfaith minister. With this new calling, I hope to serve our church by enhancing the congregation's knowledge of the wider community, and in turn, acquainting the wider community with Unitarian Universalism. I also hope to engage both the church and the community in more interfaith dialogue. My interfaith efforts this past year included organizing Fulbright Scholars from Iraq to speak at the church and working with a team of community members on a weekend of events celebrating the legacy of Dr. Martin Luther King.

Reverend Melissa Carvill-Ziemer has been an ongoing source of guidance and inspiration for me over the years. I am looking forward to having the opportunity to repay her in a small way by serving as one of a number of individuals who will fulfill Rev. Melissa's responsibilities while she is on maternity leave.

It is with deep gratitude that I thank this church community for providing me with invaluable support and friendship throughout my spiritual and educational journey. I am looking forward to taking an active role with the vibrant and dedicated friends and members of this congregation as we collectively pursue our vision.

#### Reports from the Board: Moderator

2012-2013 has been a year of transition and experimentation. The Board of Trustees has mindfully spent the year appreciating the grace of service and reflecting on the changes created by moving to policy based governance. It has been a joyful experience.

Church boards under policy-based governance spend less time on details and try to have more time to reflect and take the "view from the balcony". This Board made progress in this shift of emphasis. Even after dealing with issues full of details, we would often reflect on the question: should we have spent board time in this manner?

With the new focus on the "bigger picture", we spent much time reviewing new policies and bylaw changes brought to the board by various committees. Personnel, finance, social justice, and fundraising are among the church groups that revised their policies and procedures. You may receive copies of these changes by calling the church office.

The endowment committee created new bylaws. The finance committee suggested revisions to current bylaw language. Both of these changes were endorsed by the Board and will be voted on at the annual meeting.

Due to the fiduciary responsibility of the UUCK Board of Trustees, we spent some time each board meeting being updated on the progress of the feasibility/expansion committee. Several times we approved expenditures to continue movement towards the purchase of property. Closure is near (at press time) on our first purchase.

As moderator, I was pleased to note the continuing evolution of our community's culture around generosity. Many, many folk shared their treasure, time, and skills this year. People increased their pledges and donated materials and their time. We have many visible gifts: new glass doors, new railings, more beautiful landscaping.

Other gifts are more hidden: breakfast before first service, paid for legal advice concerning endowment, clearing of weeds and poison ivy in the back of the churchyard among others. Our endowment has grown with Simple Gifts. Treasurer Sandy Eaglen and former treasurer Kay Eckman and Congregational Administrator MaryBeth Hannan spent many hours on an application for our own 403C status. Once achieved, many members will be able to make donations to the Church that their corporate employers will match.

The Board itself owns another aspect of generosity growth. This year's and last year's Board members made a commitment to a monthly congregational activity. Thus we had quarterly information meetings. We hosted a service auction dinner both years and also hosted two appreciation events. The "hanging of the greens" became a Board event. This year we were treated to a membership coffee with new members.

On a personal note, I want to thank the congregation for the privilege of being the moderator for the Unitarian Universalist Church of Kent. I have learned a lot, laughed a lot, and enjoyed being in community with the wonderful 2012-2013 Board of Trustees and with Rev. Carvill-Ziemer. I look forward to chairing the Leadership Development Committee for next year.

#### Reports from the Board: Treasurer

Following a second successful stewardship campaign organized around the program-based budget which was implemented last year, we are ending our 2013 fiscal year on solid financial grounds which will enable us to continue maintaining and growing our programs and ministries. Our proposed FY13 budget will allow us to: support a three-month leave for our incredible minister as she and her partner welcome their new family member in the fall; provide a modest COLA increase for our hard-working staff; add a part-time RE assistant; meet naturally-increasing expenses (utilities, insurance, etc.); continue to pay our fair share contributions to the UUA and OMD; increase budgets for several programs; and maintain our contingency fund. Here are just some of the many factors that have contributed to our shared success:

The FY13 Stewardship Team, chaired by Marion Yeagler and Kay Eckman, worked efficiently and effectively to spearhead a campaign which brought in \$220,545 in pledge commitments, a 6% increase compared to our last fiscal year.

Once again, our staff, along with the very capable management of MaryBeth Hannan, have been vigilant in watching expenses while continuing to provide excellent and consistent service.

The Fundraising Committee, led by dynamo Meg Milko, developed a thoroughly-articulated fundraising policy and has been very active, providing a monthly fundraising event in addition to this year's highly successful Service Auction which was made possible through their efforts as well as those of Jen May and Lois Weir and other hard-working volunteers. The Committee's plans also include a UUCK presence at this summer's Kent Heritage Festival.

Bob Erdman and Carol Gould have worked faithfully every week to administer our successful grocery card program which now includes both Giant Eagle and Acme cards.

Others, too, have been instrumental in our ability to effectively monitor and administer our fiscal needs:

Angela Barzizza-Young has continued to serve admirably as Assistant Treasurer.

The Finance Committee, led by Gene Wenninger, has provided excellent oversight of our financial affairs including the preparation of our proposed FY14 budget. The Committee, working through a subcommittee of Gene, Carol Gould, and MaryBeth Hannan and with the assistance of the Endowment Committee, has been very busy developing several new fiscal policies for the Church Finance Policy and Procedures Manual which include, among others, a Gift Acceptance Policy and Implementation and an Endowment Investment Policy and Procedures.

The Endowment Committee, chaired by Bob Erdman, has ably monitored our two steadily growing contribution programs, Simple Gifts and the Heritage Program.

The Capital Campaign and Expansion Committee has provided oversight of our early gifts to the campaign funds and purchase of property.

Financial Secretaries and alternates Ann VerWiebe, Kathy Wilen, Eric Van Baars, and Saunis Parsons have labored tirelessly each week with several other volunteer helpers to manage our increasingly complicated Sunday contribution processes.

In addition to all the people who have contributed to making this year such a success, we have also, with much guidance from MaryBeth Hannan, made some procedural improvements:

A change in our accounting software program from ICON to QuickBooks;

An application for an individual UUCK tax-exempt status—though we are under the UUA's exempt umbrella, individual status will enhance our ability to support donors' access to contribution records for tax purposes; also allowing for greater ease of corporate donation matches

The use of PayPal for online electronic payments and contributions.

All in all, this has been a very busy and productive fiscal year. This past fall, our UUA consultant Bill Clontz suggested that two successful stewardship campaigns in a row should put us in a good position to move forward with our capital campaign efforts; it's gratifying to report that this has, indeed, been accomplished through the wonderful generosity of our congregation who contribute so much of their time, talents, energy, and financial support to our beloved church community. Working together, we can continue to make wonderful things happen.

Below you will find a brief summary of our activities, following within alphabetical order:

The Adult Religious Exploration Committee has completely reformed itself. ## Reports from the Board: Trustee for Fellowship

Areas where we can be more effective are: focusing on and sustaining our efforts in telling our story as a church community and having more conversations between the membership and stewardship committees about regular financial giving as a "core element of membership" (p. 7).

The membership committee has addressed these suggestions by interviewing new members and highlighting these interviews in the church newsletter. The conversation of regular financial giving and membership continues to be addressed at each New UU class. Connections between the membership committee and stewardship campaign committee have been fostered through the work of Marion Yeagler, who co-chaired the stewardship campaign, and by myself, who participated in canvassing members and friends of our congregation. In the future, both committees would benefit from continued collaboration to build our membership and financially sustain our community.

In closing, our membership committee is full of dedicated and hardworking people who help to grow and sustain our membership; as well as foster connections within our community. ## Reports from the Board: Trustee for Outreach to the Wider World

2012-2013 has been a year of transition in the organization of our social justice activities at the church. With the growth in our congregation from a small to a mid-size church, some of us who have worked in social justice felt the need to implement more effective ways to engage the whole congregation in this important work. We saw that the number of people active in formal social justice work through the church had diminished over time. We sought to move beyond having a small group of activists who might be viewed by others as a clique to involving as many church members as possible in social justice efforts. We also hoped to make our social justice work more action-focused and to reduce the number of meetings that church members and friends would be asked to attend. We therefore undertook a reorganization of our social justice efforts to achieve these goals.

Since 2005 our social justice work had been organized through a social justice committee. In the fall of 2012, Reverend Melissa and I investigated alternative ways to organize social justice work. We learned that, according to the UUA, social justice committees usually work best in small churches. Mid-size churches are better able to organize social justice work through a variety of distinct task forces. Melissa and I developed a proposal for reorganization that would close out the work of the social justice committee and replace it with a task force structure. We asked the social justice committee to review the proposal, and we presented the proposal to the church board. Some members of the social justice committee expressed concern that this new structure might leave people out or might extinguish our social justice efforts entirely. Because of these concerns, we chose to adopt the new structure on a trial basis to determine if it will suit our congregation. Both the social justice committee and the church board endorsed our restructuring plan, and we proceeded to implement it.

The following is the new structure that we have adopted:

#### New Church Social Justice Organization

Goals of the social justice organization:

To facilitate activism by church members on significant social justices issues in the community and the world.

To facilitate the education of church members and community residents on significant social justice issues.

To facilitate the envisioning of and planning for future social justice endeavors.

Proposed New Structure:

## Social Justice Visioning Committee

The Social Justice Visioning Committee is charged with discussing important social justice issues and envisioning ways to educate and engage the congregation in social justice work. This committee may organize educational activities at the church and elsewhere.

#### Task Forces

The task forces are charged with organizing opportunities for social justice action and education that are easily accessible by members of the congregation. Each task force will focus on a specific issue area.

The specific task forces when this plan takes effect will be the following:

Hunger and Poverty Task Force. Environmental Issues Task Force. Human Rights Task Force.

#### Social Justice Coordinating Group

The Social Justice Coordinating Group is charged with overseeing the social justice work of the church and ensuring that the congregation is actively engaged in social justice efforts.

The Social Justice Coordinating Group is charged with coordinating the activities of the task forces and visioning committee and with consulting and assisting those groups.

The Social Justice Coordinating Group selects the recipients of monthly congregational special offerings for social justice. Any church member may propose to the group a potential recipient of a special offering.

The Social Justice Coordinating Group approves the disbursement of funds for social justice projects and other expenses related to social justice.

The Social Justice Coordinating Group receives, evaluates, and approves proposals for new task forces.

The Social Justice Coordinating Group consists of the Trustee for Outreach to the Wider World and representatives from each of the social justice task forces and the social justice visioning group. The minister will serve in the coordinating group ex-officio. The Trustee for Outreach to the Wider World will chair the Social Justice Coordinating Group.

The Social Justice Coordinating Group will meet quarterly.

An executive committee of the Social Justice Coordinating Group will make decisions requiring immediate action on social justice issues. The executive committee will consist of the coordinating group chair, a coordinating group member, and the minister.

Procedure for adding a new task force to the congregation:

To create a new social justice task force, a group of church members must submit a written proposal to the Social Justice Coordinating Group. The proposal must be signed by at least five

members of the congregation who pledge to work on this issue. The proposal must include a statement of the mission of the task force and an action plan for the work that the task force will try to accomplish in the year ahead.

In creating the new structure, we needed to reorganize the oversight and disbursement of social justice funds. Our social justice work has not been funded through the church budget. Instead, the sale of fair trade products generates money that in the past went to the social justice committee. We decided with the new organization to continue raising funds for social justice through the sale of fair trade products and to have the church bookkeeper oversee all social justice monies and retain them in a special social justice fund within the church accounts. The social justice fund is reserved for social justice endeavors. We also decided to have the church bookkeeper or assistant treasurer disburse money from the monthly special offerings to the designated recipients of these offerings. We have donated \$500 yearly from fair trade sales to the church for the purchase of coffee and tea for coffee hour. We hope to continue the practice of donating money from fair trade sales to the church to fund coffee hour.

I am pleased to report that we have implemented the new structure, and we are making it work. We have chairs of all of the task forces, and the task forces have been busy organizing activities. Andrew Rome is the chair of the Environmental Issues Task Force. Elaine Bowen is the chair of the Hunger and Poverty Task Force. Susan Poole is the chair of the Human Rights Task Force. Ted Voneida and Sally Burnell are co-chairs of the Social Justice Visioning Committee. We invite church members and friends to inquire about these task forces and to get involved in activities that interest you.

We have also created a social justice web page on our church website, and we regularly post announcements there of upcoming social justice activities. These announcements appear on the church Facebook page as well.

In addition to reorganizing our social justice structure, we have joined as a church a new group in Ohio called UUJusticeOhio, a statewide network of UU churches active in social justice work. Here is a link to the UUJO website: <u>http://ohiomeadville.org/uujo/</u>

We are eager to involve as many of you in social justice work as we can. You can get involved in whatever work interests you, from donating food to volunteering at the County Clothing Center, to helping with ecology projects, to attending an educational program at the church. We hope that our new structure enables everyone to get involved as they are able. Please stay tuned for more information about how you can get involved.

Whoever you are, we welcome you to the work of social justice.

### Report from the Music Committee

The UUCK Music Committee was reestablished in Spring 2012 to support musical excellence at the Unitarian Universalist Church of Kent. The committee assists the Music Director in planning, preparing, and coordinating music programming. The Committee generally meets every other month for discussion and to establish development goals.

The reestablished Music Committee has had a successful year, despite a few stumbling blocks as we struggled with committee memberships and the resignation of our chair at the beginning of 2013. Nevertheless, we've been able to achieve most of the goals we set for ourselves over the past year. Funds received from last years' budget request allowed us to purchase new music for choir, contributing to one of the most effective choir seasons ever. Fundraising from two benefit concerts – one from Hal Walker and Matt Watroba and another at which we hosted the Zeng Quartet from KSU – permitted us to hire Wendy Mann-Packer as a choir accompanist, further contributing to quality of the UUCK music program. We also hosted a successful concert by another KSU student musician, cellist Andrea Beltran Landers. Finally, our primary mission has been to coordinate performances by guest musicians for those Sunday services when Hal is away.

Our plan for the upcoming year is to use budgetary funds to continue to attract a wider selection of guest musicians and to enable the purchase of additional pieces for the choir. Other projects include establishing an electronic database of sheet music owned by the church and possibly sharing music resources with other churches in our district. We will also continue our efforts to develop a regular a Children's Choir, supported by an adequate volunteer staff.

The Music committee members are Diana Watt, Dave Watt, Mark Eckman, and Jesse Young.

## **Report from the Religious Education Committee**

This committee meets monthly with Karen Lapidus, the Director of Religious Education, and supports her work providing religious programming for infants, children, and youth in our congregation. ## **Report from the Church Library Committee**

The Library Committee for 2012-2013 has consisted of Martha Kluth, Co Chair, Ann Waters, Co Chair and Publicity, Kathy Wilen, Secretary, Carolyn Schlemmer, Cataloger, Matt Cox, Website, with additional committee members: Andrew Bores, Harry Noden and Larry Cole. We have regular monthly committee meetings and generally bi-monthly work parties to process books and evaluate donations. The committee has continued with current projects as well as starting on some new ventures. A summary of our year's activity follows.

#### Public Programs

On February 3, 2013, Mara DeMattia of Kent presented a program on archiving the work of deceased Kent artist, Robert Wood, at our Library Speakers' Forum. Ann Waters organized the program, and it was followed by refreshments and conversation. Forty-three people attended. A free will offering was taken for the library. We had available an updated informational pamphlet about the library which was put together by Andrew Bores.

We have purchased the 3 DVD set Bill Moyers on Faith & Reason. Harry Noden is working on plans for the coming year to organize a group to meet together, listen to the video and discuss it.

### Changes This Year

Carolyn Schlemmer became the cataloger, and Ann Waters and Martha Kluth became co-chairs. Carol Gould of the church donated a laptop to the library. It was worked out very well for our cataloger. We added new categories, "Humanism" and "Inspiration." Matt Cox has been working on the website for our committee, and we have had more of a presence in the church as a result. Ann Waters forwards the publicity items to him. Matt received his Master of Library and Information Science from Kent State in 2012.

#### Here We Have Gathered

We took on the publication of the Church's chapbook, Here We Have Gathered, as a fundraiser for the library. This consists of articles about the past and present activities and people of our church. Caroline Arnold was editor of this issue. Paulette Thurman, Andrew Rome, and Martha Kluth assisted on the editorial board. When the issue came out in the fall, Ann Waters organized a sales campaign, and we raised \$142.00 for the library.

#### Library Catalog and Added Volumes

Our library catalog continues to be available on-line due to the good work of Carolyn Schlemmer. Between May 2012 and the end of April 2013 we added 40 donated or purchased books or AV materials.

#### **Congregational Survey**

We are in the process of preparing a congregational survey about the library which we hope to distribute by the end of May, 2013. We will evaluate the results in terms of suggestions for our library. Also, doing a survey gives us some public exposure in the congregation.

#### Display of Books Recommended by Our Minister

Harry Noden and Ann Waters have worked on a display of books from our collection that are recommended by our minister. The first books were set out April 21, and they will be changed every two weeks.

#### Sources of Income

Our income this year has been from a yearly donation from the fundraising committee, the proceeds of Here We Have Gathered and free will donations. We have applied for a line item of \$100 in the church budget for 2013-2014.

#### Job Descriptions

In the spring of 2013 we are attempting to examine the jobs on the committee in order to avoid having too much for one person to do and to have data for soliciting new members or volunteers. We also need to have enough help to devote more time to keeping up with overdue or missing books and to making decisions about retention of books or other items in our collection.

#### Future Plans

Short-term goals include completing our survey, considering our job descriptions, and planning a discussion group. Our long-term goals are to devote funds to increase our collection, to consider whether to sponsor future speakers, and to keep in mind the ideas we have developed about the future of the library space.

## **Report from Walden**

Walden, named after the temporary residence of transcendentalist and visionary, Henry David Thoreau, has evolved over the years into group camping experiences and exploration of the "interdependent web of all existence of which we are a part".

Some activities over the past year have included hiking Pennsylvania's Kinzua Viaduct, which once stood as the world's longest and highest railroad bridge until a tornado in 2003 toppled 11 of its 20 towers.

During our campout this past autumn, we were introduced to passive technologies modeled after wetlands which act as natural filtering agents to combat abandoned mine drainage into local streams . This was a hands-on experience where we tested water quality at various points. It was a heartening and hopeful experience to discover living organisms in water that was once mine-acid discharge. Our guide was a member of the Slippery Rock UU Congregation and some of us accepted an invitation to attend their Sunday morning service on the north shore of Lake Arthur.

There is not a set schedule and Walden participants are free to pursue their own interests. Activities may include hiking, canoeing/kayaking, bicycling, bird and wildlife watching, fishing or sitting under a tree. Get unplugged.

Immediate plans for spring Walden include camping on the Allegheny River at a former Seneca campsite. Suggested activities include a visit to the Audubon Center and Sanctuary (the naturalist is a member of the Jamestown, NY U.U. group), a visit to the Roger Tory Peterson Museum in Jamestown, hiking some great local trails and canoeing/kayaking the Conewango Creek or the Allegheny River.

Walden involves tent-camping and an indifference to precipitation "referred to as anti-rain". We usually camp in a primitive area (water, fire ring and vault toilets being the only amenities). This spring, we will be in a full-service campground with hot showers, RV hook-ups, etc. This will help ease newcomers into the Walden experience.

Future plans include meetings to discuss more possible future local activities, possible fundraisers and input from everyone.

## FY2013 Annual Program Area Reports: Income Generation

### Report from Endowment Committee

When the Consultant was in from UUA, he had some interesting ideas, and a Task Force was put together to investigate some of these. In the fall of 2012, a new member was appointed to fill an unexpired vacancy. Since then, the Committee has consisted of Cheryl Casper [Term expires June 2014], Bob Erdman [Appointee and Chair; Term expires June 2015 if the congregation approves the appointment at the June 2013 meeting] and Kristofer Sperry [Term expires June 2013].

We began FY13 with \$500 in the Endowment Fund. The Task Force, Treasurer and Minister put together some legacy brochures in the fall of 2012, which encouraged various kinds of donations. Thanks to this effort, and all those who made Simple Gift and other endowment donations, we now have over \$1500 in the Endowment Fund. Some members of the Task Force agreed to continue as an ad hoc Legacy Committee; Carol Gould agreed to Chair this Committee.

The Endowment Committee worked with the Finance Committee to develop a Gift Donation Policy for the church which covers all donations, including the Endowment Committee. We also developed an Endowment Fund Investment Policy. Both of these were reviewed with the Finance Committee, and the Treasurer presented them to the Board, who approved them in April.

In the coming year or so we expect to develop a disbursal policy for the Endowment Fund. We do not see disbursing any money from the Endowment Fund until it exceeds an amount to be determined, but probably something like \$100,000 or more.

As a church, we made some progress on growing an endowment fund and setting up policies for the Fund. With continued support and work on the policies, this will continue to grow and we will have a strong endowment fund for the long-term benefit of the church.

## Report from the Grocery Card Committee

In August 2012, we started selling Giant Eagle as well as ACME cards. This was done to increase the revenue contributed from this operation, which has a very high rate of return: 5% profit per order. For Acme Cards, we order every 2-4 weeks, corresponding to an annual rate of return on the initial \$2000 investment of around 60% and so far 3 Giant Eagle orders have been placed. The \$2500 investment in Eagle Cards was charged as negative revenue against the Grocery card Account. FY13 revenues are expected to be about \$2200, paying back all but \$300 of this \$2500. So far, about \$1260 has been paid back and another \$1240 is expected to be paid back by June 30, 2013. Average weekly sales of Acme cards is about \$650, and average of Giant Eagle cards is just over \$300.

In FY14, we plan more articles about the cards, and sometime in FY13 or early FY14 we hope to be able to announce the capability to accept credit card payments for grocery cards.

We sincerely thank the many people who now regularly buy grocery cards from the church rather than spending cash at ACME and Giant Eagle stores.
